

***Kapālama Kai***  
***Halloween Scavenger Hunt***  
**SWEEPSTAKES OFFICIAL RULES**  
**(“Sweepstakes Rules”)**

**NO PURCHASE NECESSARY**

**1. PROMOTION PERIOD:**

The Kapālama Kai (Kamehameha Schools) *Halloween Scavenger Hunt* Sweepstakes (“Sweepstakes”), begins at 10:00 AM Hawai‘i-Aleutian Standard Time (“HAST”) on Saturday, October 5, 2024 and ends on Saturday, October 5, 2024, at 2:00 PM HAST (“Promotion Period”).

**2. ELIGIBILITY:**

The Sweepstakes is open only to legal U.S. citizens (present in Honolulu, HI, during the Promotion Period) who are 18 years of age or older and the age of majority as of October 5, 2024. No purchase necessary. The following individuals are ineligible to participate in the Sweepstakes:

- A. Directors, officers, employees, and agents of Kamehameha Schools, Olomana Loomis ISC and their subsidiaries, affiliates, and advertising and promotional agencies.
- B. The immediate families of the group in section 2.A., including, but not limited to, their spouses, children, siblings, parents, in-laws, grandmothers, grandfathers, grandchildren and any spouse thereof.
- C. A person residing in the same household as any of the groups in sections 2.A. through 2.B.

**3. SPONSOR:**

The Sponsor is Olomana Loomis ISC, Inc. (“OLISC”), 900 Fort Street Mall, Ste. 1548, Honolulu HI 96813.

**4. HOW TO ENTER:**

- Entrants must complete a minimum of 4 clues on their Halloween Scavenger Hunt game card, complete the contact information at the bottom of the game card and return it to the Kapālama Kai booth at the Taste of Kalihi Market to be entered to win. Entrants who complete a minimum of 4 clues will be entered into a drawing to win a \$50 Foodland gift card. Entrants who complete all 8 clues will also be entered into a second drawing to win a \$100 Foodland gift card.
- All entries must be received during the Promotion Period (10:00 AM - 2:00 PM HAST on Saturday, October 5, 2024).

All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Sponsor will not be responsible for entries excluded or deemed

ineligible due to reasons beyond their control, including, but not limited to, lost, late, mutilated, incomplete, illegible, or unintelligible entries, or technological failures of any kind, or reasons due to the method of delivery or service.

Entries are limited to one per person.

## **5. RANDOM DRAWING AND PRIZE:**

Prize ("Prize"): There will be (2) prizes available:

- One (1) \$50 Foodland gift card.
- One (1) \$100 Foodland gift card.

The winner of each gift card will be selected in a random drawing conducted by OLISC on or about Monday, October 7, 2024 from among all eligible entries received.

- The winner of the \$50 Foodland gift card will be selected in a random drawing from among all entrants who completed a minimum of 4 clues on their Halloween Scavenger Hunt game card.
- The winner of the \$100 Foodland gift card will be selected in a random drawing from among all entrants who completed all 8 clues on their Halloween Scavenger Hunt game card.
- Each entrant may win up to one time. The \$50 gift card winner will be randomly drawn before the \$100 gift card winner is randomly drawn from the remaining pool of eligible entrants. An entrant who wins a \$50 Foodland gift card is not eligible to be randomly drawn for a \$100 Foodland gift card.

Odds of winning are dependent upon the number of eligible entries received. Each potential winner will be notified via email from Kapālama Kai and must respond within 48 hours to confirm eligibility and coordinate prize pickup by October 16, 2024. At the sole discretion of the Sponsor, an alternate winner may be drawn in the event OLISC is unable to contact the potential winner, if the potential winner does not respond within 48 hours of drawing, is ineligible, or is unable to pick up their prize by October 16, 2024. Winners are responsible for any and all federal, state and local taxes, if applicable, and must provide OLISC with valid identification before the prize may be awarded.

Prize cannot be substituted, assigned, transferred, or redeemed for cash; however, Sponsor reserves the right to make equivalent prize substitution at its sole discretion if the advertised prize becomes unavailable. Winner is responsible for any loss of prize after it has been delivered. Sponsor will not replace any lost or stolen prize. OLISC will arrange for the prize to be made available for pick up in Kapālama Center (1210 Dillingham Blvd, Honolulu, HI 96817) on a date before October 16, 2024 during the hours of 8:00 a.m. HAST and 5:00 p.m. HAST.

## **6. GENERAL:**

By entering the Sweepstakes, you agree: (a) to be bound by the Sweepstakes Rules; (b) to release and hold harmless the Sponsor (Olomana Loomis ISC) as well as Kapālama Kai and Kamehameha Schools,) including their stockholders, directors, officers, employees,

subsidiaries, agents, prize suppliers, and representatives from any liabilities, claims, damages, or losses arising out of or relating in any way to the acceptance, use, misuse, or possession of any prize received in the Sweepstakes; and (c) to allow Sponsor, Kapālama Kai and Kamehameha Schools to use, without additional compensation, notice, stipulation, or approval, your name or photo and/or likeness and other personal information for advertising or publicity purposes in any media; and (d) to bear sole responsibility for any taxes or other liabilities and obligations resulting from the acceptance and use of any prize.

Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in their sole discretion and in the event of cancellation, prizes will be awarded via a random drawing from among all eligible online entries received prior to cancellation and all eligible paper entries received. Inaccurate, fraudulent, or falsified entries or failure to comply with the Sweepstakes rules may result in disqualifications or forfeiture of prize at the sole discretion of Sponsor.

**Neither Sponsor nor Kapālama Kai nor Kamehameha Schools will provide any warranties or guarantees with respect to the prizes, expressed or implied, including, but not limited to, the implied warranties or guarantees of merchantability, appropriateness, fitness for a particular purpose, competency, safety, or security of the prizes.**

**If any provision of the Sweepstakes Rules is held to be unenforceable, it will be modified so that it is enforceable to the maximum extent permitted under applicable law and all other terms will remain in full force. If the unenforceable provision cannot be so modified, it will be excluded from the Sweepstakes Rules, and all other terms of the Sweepstakes Rules will remain in full force.**

**Disputes:** Except where prohibited by law, entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of Hawai'i or the appropriate state court located in Hawai'i; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (c) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Hawai'i, without giving effect to any choice of law or conflict of law rules (whether of the State of Hawai'i or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Hawai'i.
